## **Arrive in Style with Subway® Curbside Pick-Up" Contest**

### **Official Rules**

**Dates: January 11, 2021 – January 31, 2021**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**THIS CONTEST IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY FCA CANADA.**

**1. SPONSOR, ADMINISTRATOR:** Subway Franchisee Canadian Advertising Trust ("SFCAT") will serve as the sponsor ("Sponsor") of the Arrive in Style with Subway® Curbside Pick-Up Contest (the "Contest"). Veritas Communications ("Administrator") will serve as the administrator of the Contest.

FCA Canada Dealer Advertising Associations' ("FCACDAA") involvement in the Contest is strictly limited to providing the Prize (defined below) for the Contest and FCACDAA is in no way sponsoring or administering the Contest.

FCACDAA includes the following entities:

**2. ELIGIBILITY:** This Contest is open only to legal residents of Canada, who are the age of majority (and in no case under the age of 18) or older in the province or territory of residence at the time of entry, who reside in Canada, and who have a valid driver's license from their province or territory of residence and valid, current insurance and are legally eligible to drive (as determined by Sponsor and/or Administrator in its sole and absolute discretion). You need not be present to win. Employees, officers, directors, agents or representatives (and their immediate families or those living in the same household) of Sponsor, Administrator, Subway Franchise Systems of Canada, ULC, FCACDAA, Doctor's Associates LLC, Franchise World Headquarters, LLC, Subway IP LLC, Subway® Restaurants, Subway® Franchisees and their respective affiliates, subsidiaries, divisions, parent and related companies, suppliers, printers and advertising, promotional and judging agencies are not eligible to enter or win. In these Official Rules, "immediate family" means mother, father, brothers, sisters, sons, daughters and/or legal or common-law spouse, regardless of where they reside. Groups, clubs, organizations, businesses and commercial and non-commercial entities cannot participate. An "Entrant" is an eligible person who submits an entry in accordance with these Official Rules.

3. **CONTEST PERIOD:** The Contest begins January 11, 2021, 12:01 a.m., E.S.T., and ends January 31, 2021, 11:59 p.m., E.S.T. (the "Contest Period"). Sponsor's servers govern in all matters with respect to time.

4. **HOW TO ENTER:** You may enter this Contest only via the entry methods described below (an "Entry").

a. **PICK-UP ENTRY METHOD:** Beginning on January 11, 2021, you may enter the Contest by (i) placing a Curbside Pick-Up Order online or via the Subway® Application from a participating Subway® Restaurant located in Canada during the Contest Period (each an "Order"), (ii) identifying the order number (the "ON") on your receipt for the applicable Order, (iii) visiting [www.SubwayCurbside.ca](http://www.SubwayCurbside.ca) (for English) **OR** [www.serviceaustationnementsubway.ca](http://www.serviceaustationnementsubway.ca) (for French) (each a "Website" and collectively, the "Websites"), (iv) clicking the appropriate links on the Websites to enter your ON for the Contest, and (v) fully completing all required information on the applicable Website form for the Contest. You must fully complete and submit all non-optional data requested on the applicable Website form (including, but not limited to, your name, your province of residence, a valid email address and telephone number). By successfully transmitting a fully completed Website entry form as directed, you will receive one (1) entry.

b. **MAIL-IN ENTRY METHOD:** Alternatively, you may receive one (1) entry by hand-printing the words "Arrive in Style with Subway® Curbside Pick-Up" Contest, your name, age, street address, city, province/territory, postal code, telephone number, and valid e-mail address on a 3" x 5" card and mailing it in an envelope to: "Arrive in Style with Subway® Curbside Pick-Up" Contest c/o Veritas Communications, 370 King Street West, Suite 800, Toronto, Ontario, M5V 1J9. Each Mail-In Entry must be individually postmarked and stamped with sufficient postage.

All Pick-Up Entries must be received by 11:59 p.m., E.S.T. on January 31, 2021, and all Mail-In Entries must be postmarked by January 31, 2021 and received by the Administrator by February 10, 2021. Proof of transmission (screenshots or captures, etc.) or attempted transmission does not constitute proof of delivery or receipt by the Sponsor's servers or Sponsor and/or Administrator. Proof of depositing entry in mail is not considered proof of delivery or receipt. No photocopied or mechanically reproduced Entries will be accepted. Illegible, incomplete and duplicate Entries will be disqualified. Entries will not be accepted from post office boxes.

If it is discovered that an Entrant has registered or attempted to register more than once using multiple e-mail addresses, telephone numbers, multiple identities, IP addresses, use of proxy servers or any other method of unauthorized entry, all in Sponsor's and/or Administrator's sole and absolute discretion, all of that Entrant's Entries will be declared null and void, Entrant will be disqualified from the Contest and any Prize that Entrant might have been entitled to receive will not be awarded to him/her. **LIMIT:** Limit one (1) entry per person per day during the Contest Period, regardless of method of entry. A “day” is defined as starting at 12:00 a.m. E.S.T. and ending at 11:59:59 p.m. E.S.T. on that calendar day. If it is discovered that an Entrant has entered or attempted to enter the Contest more than one (1) time per day, all of that Entrant’s entries will be declared null and void, Entrant will be disqualified from the Contest and any Prize that Entrant might have been entitled to receive will not be awarded to him/her.

**5. PRIZES AND APPROXIMATE RETAIL VALUE:** There will be one (1) prize awarded, subject to these Official Rules. The prize (the “Prize”) shall consist solely of one (1) 2021 model year Jeep® Canada Compass vehicle, as determined by the Sponsor in its sole discretion.

To the fullest extent permitted by applicable law, Winner understands and acknowledges that he or she may not seek reimbursement or pursue any legal or equitable remedy from any of the Released Parties (as defined below) should the Prize fail to be fit for its purpose or is in any way unsatisfactory. That message will ask the selected Entrant to contact the Sponsor and/or Administrator in order to claim the applicable Prize.
